ORDINANCE NO. 2023-2

**AN ORDINANCE OF THE COMMON COUNCIL
OF THE TOWN OF GENEVA, INDIANA**

**FOR THE REGULATION OF TRAFFIC WITHIN THE TOWN OF GENEVA,
AND AMENDING CHAPTER 73, SCHEDULE H OF THE GENEVA TOWN CODE
BY THE DESIGNATION OF A FOUR-WAY STOP INTERSECTION**

WHEREAS, the Town of Geneva has been adopted the Geneva Town Code of Ordinances which includes traffic rules and the designation of stop intersections throughout the Town; and

WHEREAS, the Common Council of the Town of Geneva ("Common Council) believes that, in order to improve public safety, there is an intersection that should be added to the four-way stop intersections as set out in Chapter 73 of the Town Code entitled Traffic Schedules.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE TOWN OF GENEVA, INDIANA, AS FOLLOWS:

SECTION I:

Chapter 73 Schedule I (H) of the Geneva Town Code is hereby amended to add the following four-way stop intersection as follows:

Line Street at Railroad Street

SECTION II:

Street signs designating the intersection described in Section I of this Ordinance to be a four-way stop intersection and notifying vehicles thereof shall be placed which shall be erected at the appropriate entrances to such intersection in accordance with Chapter 73 Schedule I (A) of the Town of Geneva Code of Ordinances.

SECTION III:


The driver of a vehicle proceeding easterly or westerly on Line Street shall come to a complete stop at Railroad Street, and the driver of a vehicle proceeding northerly or southerly on Railroad Street shall come to a complete stop at Line Street, as required by state law and in obedience to the stop sign at the intersection where a stop sign is erected at the entrance thereto, before proceeding into the intersection, unless traffic at such intersection is controlled by a police officer on duty, in which event the directions of the police officer shall be complied with.

SECTION IV: The penalty for violation of this Ordinance shall be according to Chapter 73 Schedule I (L) of the Town of Geneva Code of Ordinances and/or pursuant to Indiana law.

SECTION V: This Ordinance shall be in full force and effect from and after its passage and due publication thereof.




