December 30, 2025 at 6:30 P.M.

Those present were asked to please rise for the Pledge of Allegiance.

The meeting was called to order by President Lynn Burry. Roll call showed Council members Andrew Briggs, Arlen Mitchel, Agnes Schoch, Stan Ringger, and Clerk-Treasurer. Town Attorney not present.

This meeting was not livestreamed on the Town of Geneva's YouTube channel due to technical issues.

**On a motion** by Andrew Briggs, seconded by Agnes Schoch, and passed unanimously, Council approved adding "4 hours for water/wastewater readings for Saturday and Sunday" to the 12/9/25 minutes as well as the entire meeting minutes for 12/9/25 and the Executive Session meeting minutes for 12/9-25.

**New Business** – Resolution 2025-2: Resolution to Manually and Electronically Transfer Balance in Excess for 2025 Budget and Appropriation Encumbrances for 2026 Budget Year was reviewed and discussed. **On a motion** by Arlen Mitchel, seconded by Andrew Briggs, and passed unanimously, Council approved Resolution 2025-2. A copy of the resolution will be attached to the meeting minutes.

**Clerk Treasurer** – Clerk Treasurer reported that Local Roads and Streets and MVH Restricted each have a shortfall \$873.18 each. DLGF and SBOA were both contacted by the Clerk Treasurer on the best way to handle this issue. It is too late to do an additional appropriation in 2025 per the DLGF. SBOA instructed Clerk Treasurer to document the issue in the event of an audit.

**Council Members** – Lynn Burry is scheduling an Executive Session on 1/5/26 to further discuss the open Workforce Manager Position and make a decision on a candidate.
